Høring – etablering av Nordiske utstillinger fra 2018

NKKs hovedstyre har, etter innstilling fra NKKs særkomite for utstilling, vedtatt å sende utkast som er utarbeidet i Nordisk Kennelunion (NKU) vedrørende etablering Nordiske utstillinger og nytt nordisk utstillingschampionat fra og med 2018, på høring til NKKs medlemsklubber og forbund mv.

Etablering av Nordiske utstillinger vil medføre at det deles ut Nordiske certifikat på disse utstillingene, i tillegg til nasjonalt cert (i Norge «stor cert»). Nordiske certifikat vil således danne grunnlag for oppnåelse av fremtidig Nordisk Utstillingschampionat.

Ved å etablere egne nordiske utstillinger og tildele nordisk certifikat vil det kunne skapes enda mer attraktive utstillinger i Norden, og medføre økt bruk av nordiske dommere. Avhengig av i hvilket omfang Nordiske utstillinger arrangeres i stedet for internasjonale utstillinger vil dette gi reduserte kostnader for NKK. Anslagsvis vil dette kunne utgjøre i størrelsesorden kr. 200.000 – 300.000 per år.

Som kjent har NKKs representantskapsmøte (RS) tidligere gjort flere vedtak knyttet til erfaring med og evaluering av NKKs medlemskap i FCI. Det vises spesielt til:

RS vedtak 2014, sak 5d:

Vedtak: Hovedstyret pålegges å utrede fordeler og ulemper med medlemskap i FCI. Utredningen skal redegjøre for hvilke tiltak som kan iverksettes for å heve NKKs kompetanse knyttet til FCI, hvorledes NKK kan utøve demokratiske rettigheter som medlem og hvordan man evt. kan bøte på de ulemper som i dag finnes knyttet til FCI medlemskapet.

RS vedtak 2015, sak 5:

Vedtak: NKKs erfaring med og evaluering av FCI skal gi grunnlag for Hovedstyrets behandling og oppfølging av NKKs medlemskap i FCI.

Hovedstyret gis fullmakt til å endre NKKs medlemskap i FCI, alternativt å begjære uttreden.

NKK avventer å søke internasjonale show for 2018.

Vedlagt følger NKUs utkast til regler for Nordiske utstillinger og nytt Nordisk Utstillingschampionat som vi ber om tilbakemelding på.

Av hensyn til videre behandling må endelig vedtak knyttet til eventuell innføring av Nordiske utstillinger fra 2018, beslattes innen utgangen av oktober 2016. NKK har jf. RS vedtaket foreløpig ikke søkt om internasjonale utstillinger for 2018. Internasjonale utstillinger for 2018 må omsøkes til FCI senest innen utgangen av desember 2016.

NKKs hovedstyret har på denne bakgrunn vedtatt at høringsfristen må settes noe kortere enn vanlig. Høringsinnspill bes sendt NKKs administrasjon v/ Aktivitetsavdelingen på e-post marianne.njoten@nkk.no senest innen torsdag 18. august 2016.

REGULATIONS FOR NORDIC DOG SHOWS

These regulations has been decided by NKU/AU on October 12, 2016 and can only be changed by NKU/AU.

These rules will be evaluated in the end of 2019 by NKU/AU and can then be changed. After this these rules will be evaluated every five years (2021).

These regulations supplement the national show regulations from the Nordic countries in respect of those dog shows in which a "Nordic Show Certificate", merit for the title "Nordic Show Champion".

Each country has the right to charge a fee for each dog entered in the show, from the club organising the Nordic Dog Show in question. The national kennel club decides on the fee. The fee stays with the Kennel Club in the country in question.

1 BASICS

The dogs' welfare and health must be of **UTMOST PRIORITY** at all dog shows according to the national show regulations.

Each Nordic country has the right to organise five (5) Nordic Dog Shows but at least one every year. In addition, each country has the right to organise one show for every 5 000 registered dogs. The number of registrations the year before applying for the show is taken into account.

The Nordic Dog Show cannot also be an FCI international show. In other words, one show cannot be both Nordic, where Nordic Show Certificates are awarded, and international, where CACIBs are awarded.

The Nordic Winner show must be a Nordic Dog Show. The largest show in each country for the year could be a Nordic Dog Show,

The catalogue of these shows must be clearly marked with the NKU-logo and the following expression: "Nordic Kennel Union".

2 APPLICATIONS

An application for the status of a Nordic Dog Show must be submitted at the latest December 31st three years before the show, by the Kennel Club in the country in question.

A working group nominated by NKU/AU coordinates the applications so that shows overlapping one another can be avoided. The date of the shows, the distance between the shows, and division of groups shall particularly be considered.

It is the task of the NKU Secretariat to draw up and publish Nordic Dog Show schedules. The shows, which have been sanctioned by the NKU.

3 CLASSES

A Nordic Show Certificate can be awarded to dogs who has participated in the following classes:

- Junior Class
- Intermediate Class
- Open Class
- Working Class
- Champion Class
- Veteran Class

Classes in which The Nordic Show Certificate cannot be awarded:

- Minor Puppy Class
- Puppy Class

4 The Nordic Show Certificate

Only one Nordic Show Certificate can be awarded in each sex, in every breed and breed variety - in accordance with the National Kennel Club Show Regulations.

All breeds recognized by the NKU can receive The Nordic Show Certificate.

The Nordic Show Certificate is awarded to the best male and the best bitch, and the reserve Nordic Show Certificate is awarded to the second best male and bitch, regardless the class the dog competed in in the first place.

When the national kennel club after the show confirms The Nordic Show Certificate, it turns out that the dog already has the Nordic Show Champion title at the date of the show, or his/her results are cancelled the Nordic Show Certificate is transferred to the dog that was awarded the reserve Nordic Show Certificate, in other words the second best male/bitch. The Nordic Show Certificate is never transferred further than this.

The Nordic Show Certificate proposals will be issued by the appropriate judges. The final confirmation will be done by the national kennel clubs.

At the Nordic Dog Show, national certificates will also be awarded.

5 JUDGES

The share of Nordic judges must be at least 50 % and at least from three Nordic countries at the Nordic Dog Shows.

Reimbursements to judges is according to the national kennel club rules and regulations.

6 NORDIC SHOW CHAMPION

The new Nordic Show Champion title replaces the Nordic Show Champion title today (which requires three national champion titles from Nordic countries).

Rules for the new Nordic Show Champion title in Denmark, Finland, Norway and Sweden:

- The dog must have the national show champion title in the country where the dog is registered
- Three Nordic Show Certificates from three different Nordic countries, awarded by three different judges. At least one of The Nordic Show Certificate's must be received after the age of 24 months.

Rules for the new Nordic Show Champion title in Iceland:

- Three Nordic Dog Show Certificates from three different judges. At least one of The Nordic Show Certificate s must be received after the age of 24 months

The application for the title Nordic Show Champion must be submitted to the Kennel Club of the country where the dog is registered. If the dog is registered outside the Nordic countries, the application is addressed to the Kennel Club in the country where the last certificate was received.

7 TRANSITIONAL RULES DURING 2018-2019

A shorter deadline for submitting applications for Nordic Dog Shows can be applied.

Exception from the rule regarding at least 50 % Nordic judges from three Nordic countries can be made.

The old and the new regulations for the Nordic Show Champion title can be used in parallel. From 1st of January 2020 only the new regulations apply.
